4. No smoking and NFPA 704M signage to be placed in accordance to fire official
5. Maintenance and repair shall be in a hangar (s) approved for that use
6. Any cleaning of parts shall have 50 feet of clearance with any other aircraft and the solution shall not be a flammable liquid
7. Metal drip pan shall be placed under each aircraft and no open flame shall be permitted in any hanger
8. Type, size, quantity and location of Fire Protection Equipment
9. Number of aircraft refuelers and product classification
10. List of qualified attendants to operate refuelers
11. List of make, year, model, vin # and capacity of any aircraft refuelers
12. List the GVW of the refuelers and a copy of the weight ticket for each vehicle to show actual weight at capacity
13. List type of grounding and bonding to be used and how fixtures will be grounded during refueling process
14. Helistops shall require sketch of these areas with regard to clearance of all structures and appliances
15. Copy of approval from Federal Aviation Agency

This application shall be considered valid as long as the above criteria, codes and local ordinances are met.

Conditions, surroundings and arrangements to be in accordance with the NC State Building Code - Fire Prevention Code. Complete plans and construction details must be filed on all major projects when requested by the Fire Marshal's Office.
